On official instigation or arrangement of the water police, the competitions may be interrupted at any time.

4. Entries and Participants

All participants must be in possession of a valid drivers' licence for their specific class. All participants must be at least 16 years old. Drivers under the age of 18 need require written permission of a guardian.

The entry fee is 35,00 Euro per boat in the class P750 Thundercats and 65,00 Euro for non-registered drivers in the class Formula 4 and Formula 5.

Registered drivers will be entered en bloc by the DMYV and do not pay any further entry fee for the event.

Drivers under the age of 18 do not need to pay an entry fee, drivers who compete in two classes only pay their entry fee once.

Although the DMYV enters all registered drivers en bloc, it is necessary that ALL drivers sign the disclaimer (for drivers under the age of 18: the guardian needs to sign!) and leave it with their documents in the race office.

The entry fee is due when the entry is placed. Entries that are not accompanied by the entry fee are not valid and will not be approved. It is possible to pay the entry fee in cash in the race office. All drivers need to name their mechanics (max. 3) and their radioman until the administrative checks (108.03)

Entry deadline is july 19th 2019, present at the promoter. Entries from foreign drivers need to carry the written permission of their national boating association (stamp and signature on the entry form).



For all entries arriving at the promoter after the entry deadline, an additional fee of 35,00 Euro (class P750) or 65,00 Euro (class Formula 4 and Formula 5) must be paid. Unpaid entries are not valid. Entry fees will not be refunded.

The organizer reserves the right to reject entries without needing to inform about the reason.

5. Authorized boats, number of races

A maximum of 12 boats is authorized for all races. The entry date is decisive in the case of more than 12 entries per class. Registered drivers for the championships have priority.

For each class that the respective course with two or more buoys marked according to the relevant regulations. The following route lengths apply for the different classes:

All races will be started by a jetty start.

6. Starting numbers

The race numbers will be communicated by the organizer together with the entry confirmation. Permanent race numbers will be accepted, if possible. The race numbers must comply with the provisions of the UIM Regulations regarding design and dimensions. In compliance with 206 UIM Regulations, boats which are not properly identified will not be classified. First time license holders shall start with red numbers on the white background.

Within these times it is strictly forbidden to drink alcohol in the paddock and in the area surrounding the cranes. Any person under the influence of alcohol is not allowed to take part in the event.

8. DMYV-Commissioner and court of arbitration:

10. Scrutineering

All drivers need to come to the race office to collect their race documents and to do the administrative checks. The following documents are necessary:

- valid international drivers licence (national drivers licence for F5) no copy, only original!
 The licences will be kept in the race office until the end of the event and until the respective driver has paid all fines. It is the driver's duty to collect the licence before the race office closes.
- insurance declaration including the required amount covered as described in these regulations
- valid medical certificate
- list including names of all team members
- formula 4 and 5: immersion test certificate (turtle test) no copy, only original!
- documentation of the valid radio licence from the Bundesnetzagentur in accordance to § 55 Telekommunikationsgesetz (TMK) no copy, only original!
- documentation of necessary medicine in relation with the latest NADA list

All drivers get a maximum of 4 tickets (wrist bands) for themselves and their mechanics. These 4 team members are allowed to enter the starting pontoon. Each driver is responsible for his/her team and that all wrist bands are carried properly around the wrist during the entire event. Drivers starting in two classes will only receive one set of wrist bands. If the wrist bands are not worn properly, the team may be excluded from the races/the paddock.

Each boat with an engine must be presented at scrutineering bevor starting the practice. The following items must furthermore be presented:

- Valid measurement certificate
- Logbook in cockpit classes (formula 4 and formula 5) according to UIM
- Helmet in compliance with UIM 2018 § 205.07 for formula 4 and formula 5 Helmet in compliance with UIM 2017 § 560.16 /§ 205.07 for class P750
- Lifejacket in compliance with UIM § 205.06
- FHR- (HANS)-device including quick release according to UIM § 205.07.01 for boats with safety cockpit
- Paddle if required
- one-piece, body-covering suit according to UIM § 205.11 for formula 4 and formula 5 one-piece, body-covering suit according to UIM § 560.16 for class P750
- Fuel receipt from the prescribed fuel station (see art. 17)

13. Responsibility and Disclaimer

Participants take part in the event at their own risk. They bear the sole responsibility under civil and criminal law for any damage caused by them or the boat used, if no exclusion of liability according these Event Regulations is agreed.

By submitting their entries, participants (competitors, drivers, boat owners and registered keepers) waive any claims or rights to pursue action for damages in connection with their participation in the event against:

- the UIM/DMYV e.V./ its members of the Board, voluntary and full-time members the ADAC e.V., his agents, officials and marshals (including craning staff)
- the participants and their team members as well as
- the own team members,
- Government agencies, racing service and all other persons involved with the organization or running of the event
- the waters' and property/ies owners on which the event is held
- the owners of the installation and facilities constructions used for the event,
- the operator of the courses used for the event and his agents.

for any kind of damage suffered in connection with the event except for damage from the injury of life, body or health which are based on the deliberate or negligent breach of duty also by a legal representative or a vicarious agent of the group of persons released from liability and except for



other damage based on a deliberate or grossly negligent breach of duty also by a legal representative or a vicarious agent of the group of persons released from liability, against:

- the other participants (competitors, riders) their assistants, the owners, registered keepers of other boats
- their own competitor, their own rider, passenger an down assistants

they waive claims of any kind of damage that originate in connection with the competition except damage from the violation of life, the body or health which based on a deliberate or negligent breach of duty also by a legal representative or a vicarious agent of the group of persons released from duty and except for other damage that is based on al deliberate or grossly negligent breach of duty.

The exclusion from liability becomes effective for all parties concerned upon submission of the entry from the organizer.

The liability waiver applies to claims for any legal reason and in particular to claims for damages based on contractual and non-contractual liability remains unaffected by the above exclusion from liability.

The agreement becomes effective for all persons concerned upon submission of the entry form to the organizer.

Responsibility of the Organizer

The organizer reserves the right to modify these Regulations if necessary for reasons of force majeure or for safety reasons or if requested by the administrative authorities and/or cancel the event if this is a consequence of extraordinary circumstances, without assuming any liability for damages. The organizer is furthermore only liable as far as no liability renunciation is agreed in the Regulations.

14. Insurances

The organizer takes an event organizer liability with the following sums insured.

2.600.000,-- EUR for physical injuries per claim, however no more than:

1.100.000,-- EUR for individual person,

1.100.000, -- EUR for material damages,

100.000,-- EUR for consequential losses.

The above insurance includes a liability insurance for all properly entered drivers (with the above mentioned sums) In addition to that the driver's helpers as well as spectators are insured by the event organizer.

All participants must make sure that they have their own personal accident insurance. German participants with a DMYV licence are insured by the DMYV. Foreign insurances will only be accepted if they are presented with a certified German translation.

Taking out an insurance on the event is possible.



The boats and vehicles parked in the paddocks will not be covered by the organizer's insurance and shall be placed there at the own risk. Craning in and out of the water of the boats is not covered by the organizer's insurance.

15. Drivers Meeting

The drivers meetings for the respective classes are held according to the enclosed schedule. All drivers are obliged to take part in the briefing that refers to their class. Not attending the briefing will lead to an exclusion of the event. The drivers meetings will be held in English close to the race track.

16. Further regulations

All practice sessions and free practice sessions as well as races and qualifyings are held in accordance with the regulations and championship regulations of the corresponding classes and the attached time table.

The races will take place on a circuit and it will be raced against the clock. The grid positions for race 1 are the results of the qualifying or of the championship's standing. Grid position 1 is placed on the left end of the starting pontoon.

After the race is finished or when the race is suspended, a cool-down lap has to be completed by all participants with particular caution until the paddock and/or the starting pontoon.

Suspending the race

A race is suspended if the race director suspends it after the start. The race director is responsible for the suspension of the race.

The race is to be suspended if one or more people are in the water e.g. after an accident as continuing the race would mean danger to life for those people in the water. The drivers causing a suspension of a race are not allowed to take part in the re-start.

A re-start will be held according to UIM § 311.02.

It is forbidden to cross the circuit on anytime.

Scrutineerings:

Boats may be checked and weight by the Scrutineers at any time (see § 515 ff., 520 ff., 542 ff. UIM regulations). After an accident during a practice session or during a race, the affected boats must be checked by the Scrutineers before a re-start.

Parc Fermé

17. Fuel / Refuelling

For all participants of each class fuel of 95 octanes from the ARAL gas station in 28237 Bremen, Stapelfeldstr. 4 is prescribed. The receipt is to be presented during Scrutineering.



18. Paddock

The paddock will be open from Friday, 26th july 2019, 5:00 pm and is guarded throughout the event period until the prize giving ceremony. Nevertheless, the organizer accepts no liability for any losses. For safety reasons, the organizer reserves the right to cause the breakdown of tents / pavilions in the paddock. Placed in the paddock will be assigned by the organizer only. A power connection with a maximum of 8000 W will be available. This may be used for loading battery packs. A suitable cable must be provided by the driver/the team. It is prohibited to park in the paddock without the permission of the organizer. The parking of vehicles outside the designated parking is prohibited. Motorhomes and service vehicles are prohibited in the paddock area. The paddock may be opened for guided tours.

19. Practice sessions

Taking part in practice sessions is only allowed after the complete technical approval of the boat and the course is placed after the water registration and according to the official schedule of the event. Training outside the race track as well as before and after the allowed times will be punished with disqualification.

Participants who own their first licence have to complete at least 10 rounds during the practice sessions before they are allowed to take part in the races.

20. Protests

Protests must be submitted in English according to UIM 403.4. The protest fee is 80 EUR. The following times are binding:

protest against scrutineering: 1 hour after the end of scrutineering against a race incident: 1 hour after the corresponding race against the results: 1 hour after the results have been published against the yellow car: 1 hour after the results have been published

Collected protests and protests against the time keeping will not be accepted.

Costs for de-mounting and mounting several parts must be paid by the participant. An advance payment of 250 Euro has to be paid.

21. Results

Results will be published on the official notice board near the paddock.

22. Awards

According to UIM § 322.01 and DMYV racing regulations part D, point 7.

23. Accommodation

Accommodation must arrange by each participant individually.

Placing motorhomes will be possible next to the event area.

24. Toilets and Showers

Toilets are available near the paddock.

25. Implementing Rules / Application and Interpretation

The organizer has the right to publish bulletins to this Supplementary Regulation which will become an integral part of this regulation. Only the Jury may adjudicate on an interpretation of the Supplementary Regulations The Jury decision shall be final.

The organizer reserves the right to do doping controls (§ 205.02.03 UIM) as well as alcohol controls at any time during the event. The blood alcohol concentration may at no time exceed the the prescribed rates (§ 205.02.02. UIM)

The cost for each destroyed turning buoy will be 125,00 Euro and must be paid by the causer at ADAC Weser-Ems e.V.


