### 3. Rules

- The races are held under the current UIM rules and homologations.
- The organizer and race directorate retain the right to announce additional rules and regulations specifically for the races mentioned in this program. These rules and regulations must be in conformity with the rules and regulations of the U.I.M. and are obligatory as any other rules and regulations of these races. Drivers must be informed about these additional rules and regulations by the race commissioner during the first official drivers' briefings. The modifications must be communicated, by written means, to the officials and participants, at least 1 hour before the first start.

- All registrations will be confirmed by the organizer. If a competitor does not receive such confirmation, they are responsible to contact the organizer to verify their registration.
- Parents/Guardian name, signature and contact information on entry form is mandatory for all participants that are under 18 years age.
- No Entry fee for UIM titled race classes.

## 6. Minimum age of competitors

- For UIM race categories according to UIM Rule 203.04.01 (16 years for F-125, F-250 and F-500)

## 7. Documents for registration and scrutineering

- Original documents must be presented and copies handed over to the Race Office.
- Original National Authority signed ratification document (UIM rule 203.01)
- Measurement certificate and racing license.
- Immersion test certificate for classes with safety cockpits.
- Documents of medical examination.
- Insurance documents in English or in local official language (see more detailed explanation further in this document).
- Signed Acknowledgement of the anti-doping rules (can be signed at registration).
- Jury members must present a signed NA authorization form at the race office before first drivers' briefing (UIM rule 402.01)
- All drivers must present their valid personal international accident Insurance Policy. If the Insurance are included on some National Authorities Racing Licenses, they must be drawn up in English.
- For times of scrutineering see Time Schedule.
- During the scrutineering all elements required by the UIM Rules will be checked and drivers must produce their engines homologation sheets.
- Practice will be allowed only after a successful technical inspection of the boat on the course at it will be laid out for the races. Practice will be allowed only during the official practice sessions as listed in the final time schedule of the event. The race course area will be closed for practice during any other time and any boat on the course during this time will be subject to disqualification from the event

- Racing course – see map in the end of this document.
- Safety lap after checkered flag is obligatory for all classes. Not fulfilling this requirement results with disqualification.

## 9. Racing format and starts

- All classes have three heats and all heats are to be considered for the results.
- All heats will have a dead engine start per UIM Rule 307.
- Starting position for first heat will be determined by time trial. Boats qualifying for first heat via second chance qualification will be positioned at the lower end of the jetty.
- Time trials will be run one-by-one. Sequence: from initial boat numbers to increasing. Qualification heats Includes 4 laps. First lap warm-up, second and third laps -timing, fourth lap - safety. After the third lap will timing - the next participant will be start.
- On the start jetty at start procedure each driver can be accompanied by a maximum three team members
- It is the driver's responsibility to place the boat on the start in time. Late starters can only join the field by following the instructions of the Jetty Marshall.
- The start will be signaled with lights.
- Late start is understood after the moment when the leading boat passes first turn buoy or red light is turned on again (explained at Drivers briefing). Such late boat will be allowed to join the race only after signal and instructions of the jetty Marshall.
- The start remains open until the first racer has made three laps.
- Race stopped will be restarted accordingly to UIM Rule 311.
- To be awarded points a driver shall have completed at least 75% of the race winner's distance and cross the finishing line after the leading boat has taken the chequered flag (UIM 317.02)

## 10. Safety regulations

- Protecting helmet per UIM Rule 205.07
- Racing vest per rule UIM Rule 205.06
- Clothing protection per UIM Rule 205.11

## 11. Fuel

- According to UIM rule 508
- Drivers in classes using alcohol-based fuel must buy and bring their own fuel.

## 12. Transport facilities and concessions

- Travel money for the F-125, F-250, F-500 in accordance with UIM Rules. Failure to send entry to race organizer no later than 28 days before the start may result in the driver losing any scheduled travel money.
- No additional compensations for travel costs or for starting in the race will be paid. All travel, transportation (delivery of the sports equipment to the event venue and back) and event participation costs to be covered at own expense except as provided by the UIM Rules.

## 13. Prizes

- The race winners will be provided with medals and diplomas of appropriate category. The first six pilots in each race class of the Ternopil event will be provided with cups.
- For UIM titled event medal winners, UIM provides gold, silver and bronze medals. All drivers and teams of each event must attend the Prize giving ceremony
- Everyone must attend the Prize giving ceremony in their team's uniform or in their national uniform. Drivers wearing non-suitable clothing for Prize giving Ceremony will not be awarded.
- The podium presentation will take place after engines and hulls inspection according to the UIM Rules.

## 14. Other mandatory regulations

- The penalty for dislodging or damaging a buoy is 100 €. The penalty shall be paid immediately at the race office. Should the responsible driver fail to pay the penalty fee, s/he is prohibited from participating the following events of the schedule. Once payment is made the driver is allowed to rejoin the events of the schedule. Remaining buoys and anchors belong to the organizer. For all buoy infringement cases UIM Rule 313.02 should be followed.
- Obligatory Drivers briefing will be held according to the Time Schedule and will be organized in the pit area near to race office (see race course map).
- The organizer reserves rights for advertisements on the boats as regulated in UIM Rules 203.051.
- Any protest must be submitted to the Race Secretary in English according to UIM rule 403. The protest fee is 80 € payable in cash at the time of lodging the protest.
- In the course of the event each boat must be prepared for the weighing procedure which shall be carried out by the technical committee. The weighing of the boats cannot be protested.
- Every driver is responsible that his engine does not exceed noise levels at all times as specified in U.I.M. Rule 505.
- Every driver is responsible to take care of the environment - an absorbent carpet to avoid any spillage to the ground must be used according the UIM Rule 703.
- Organizer will make Letter of Invitation for Visa supply for participants if necessary.

## 15. Insurance regulations

 If insurance is included in the racing licenses of some National Authorities such documents must be written in English. In case of absence of valid third-party liability insurance at the time of driver registration, it will be available for purchase from the organizers for 90 EUR.

## 17. Organizer additional regulations

- Each driver receives the Race Instruction from the Race Secretary when registration.

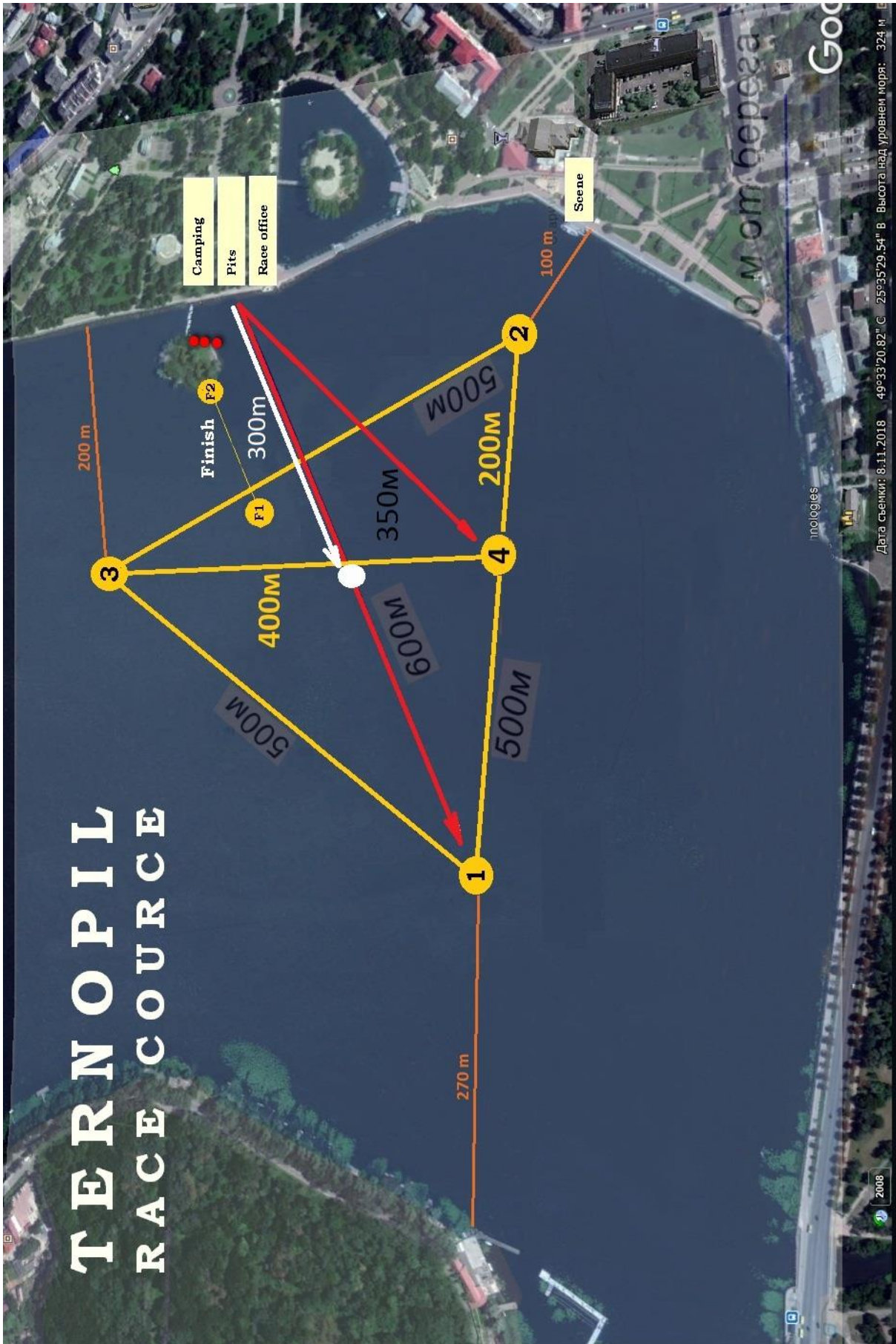


- For F-500: launch of the boats into the water shall be performed with two cranes in specially marked places only. Instructions of crane operators must be observed at all times during the launch of the boat into the water. Equipment must comply with the U.I.M. rules (rule 205.12). F-125 and F-250 boats can be launched also by hand.
- Drivers and mechanics should follow the UIM rule 205.02.02 concerning alcohol and drugs. Random tests may be carried-out at any time during the event.
- Organizers in no way shall have any responsibility towards the drivers, mechanics, or other participants of the event for any material damages incurred during or in connection with the event. Boat drivers and other participants acknowledge they the fully aware of risks associated with participation in the races and shall take part in the races at their own risk.
- Accommodation of the event participants and guests outside the sports camp is of free choice. Participants and guests can choose any of the nearest hotels. Refer to the Hotel Information below for full details.
- Participants and guests will be able to stay in their own trailers and tents at the special area (camp) next to the race area.
- Participants and guests will be able to buy food at the supermarkets and canteens next to the boat parking area.

### 18. PIT area

- Boat parking area is closed and secured. At night-time (ACCORDING THE SHEDULT) the boat parking area is closed and will be guarded – staying there is not allowed. Any open fire or smoking shall be strictly prohibited in the PIT area.
- Each team or group will have their space for parking the boats.
- PIT area shall be closed, secured and restricted territory available to the technical staff of the teams, drivers and their equipment only. All technical preparation of the boats and their launch into the water shall be performed at the PIT area.
- No animals shall be allowed in the PIT area.
- PIT area passes shall be provided by the organizers at the time of arrival of teams. Each team is responsible for indicating number of necessary PIT area passes at the time of application.
- As per UIM Rule 108.04: "When entering a UIM Titled event, each driver must indicate the names of his/her mechanics/associates authorized to enter the Pits. These names must be then confirmed / verified at signing on schedule."
- Any violation in the PIT area shall be subject to a fine. Teams shall be informed about the applicable fines at the time of registration and posted on designated board in the PIT area. Pits Officer shall bear sole responsibility for ensuring compliance with rules in the PIT area. Decisions of Pit Officer shall be final and not subject to appeals. To be applied to all people in the paddock: A Blue Card can be given by the UIM Commissioner for any offensive, unsportsman, abrasive, etc. behavior during any official activity (briefing, race control during event, etc.) A second Blue Card will immediately remove the offender from that activity. Following the subject activity, the Race Jury will meet and determine if further disciplinary action is justified. UIM Rule 406.05.

## RULES OF ENTRY TO UKRAINE

**Resolution of the Cabinet of Ministers of Ukraine of June 23, 2021 № 657 amended the resolution of the Cabinet of Ministers of Ukraine of December 9, 2020 № 1236.**

All foreign citizens regardless of the country of arrival to enter Ukraine must have a policy (certificate) of insurance issued by an insurance company registered in Ukraine, and covers the costs related to the treatment of COVID-19, observation, and is valid for the entire period of stay in Ukraine.

All foreign citizens, holders of a temporary residence permit, as well as stateless persons need to have one of the following documents:

- **a document confirming the receipt of a full course of vaccination against COVID-19 with vaccines included by WHO in the list of approved for use in emergency situations; or**
- **a negative rapid test for the SARS-CoV-2 antigen (RAT, Ag) that was done no more than 72 hours before entry; or**
- **a certificate of a negative PCR test result done no more than 72 hours before the entry.**

Test, vaccination and self-isolation are not required for children under 12.

Ukrainians and holders of a permanent residence permit are exempted from the requirement to have or undergo testing and / or self-isolation with the installation of the Vdoma application when returning to Ukraine from any country in the world except India, Great Britain, Russia or Portugal (from July 2, 2021).

From July 2, 2021, all foreign citizens, citizens of Ukraine, holders of a permanent or temporary residence permit, stateless persons who arrive from **India, Great Britain, Russia or Portugal** or have been on their territory for more than 7 days during 14 days, they are required to undergo a rapid test to determine the antigen of the SARS-CoV-2 coronavirus at checkpoints (control points) across the state border.

PCR tests for coronavirus infection required for travel to EU countries can be taken at any certified laboratory in the city of Ternopil, subject to payment for medical services. The cost of such testing in the city is about 30 €.

## **NATIONAL UKRAINIAN POWERBOAT FEDERATION: COVID-19 special rules**

1. Failure to comply with the COVID-19 rules may lead to disqualification and immediate exclusion from the event.
2. Teams cannot arrive to the pit area earlier than 06.00 26 August .
3. Due to limited space in the pit area, you will be assigned a space by the Pit Marshal at arrival.
4. Every team has to provide their own face masks and hand disinfection.
5. There is a team size limitation due to the COVID-19 situation that will be strictly enforced at the gate to the pit.
6. Staying in closed spaces is allowed only under following conditions:
  - Facemasks must be worn at all time
  - Social distancing must be kept to a minimum of 1,5 meters at all time
  - Team members should strive to remain within their assigned space during the event
  - Hands disinfection will be required upon entry to pit and shall be used regularly
  - No direct symptoms of illness as: body temperature above normal, cough, runny nose, shortness of breath or similar
7. All drivers and team members are to declare in writing in Race Office that, to the best of their knowledge, they are not infected and are not in quarantine or epidemiological surveillance before the event.
8. All drivers and team members are to declare in writing their contact data and phone number in order for quick contact in case of epidemiological investigation.  
Those data will be kept secret and destroyed after the event plus possible infection time.
9. Organizer may control any person's body temperature through out the event.

Dear Mr. Mercadier,

Pursuant to the Resolution of the Cabinet of Ministers of Ukraine of June 2, 2021 No 583, in connection with counteracting the spread of acute respiratory disease COVID-19 caused by coronavirus SARS-CoV-2 (hereinafter - COVID-19), foreigners and stateless persons crossing the state border to enter Ukraine must have the following documents/certificates:

1) insurance policy (certificate) issued by an insurance company registered in Ukraine or by a foreign insurance company with representative office in Ukraine or with a contractual relationship with a partner insurance company in Ukraine ("assistance"), which covers costs related to COVID-19 treatment, observation, and is valid for the period of stay in Ukraine;

2) negative results of COVID-19 polymerase chain reaction test or a rapid test for coronavirus antigen SARS-CoV-2, obtained within 72 hours before crossing the state border, or a document confirming the full course of COVID-19 vaccination by vaccines included in the WHO list of vaccines permitted for use in emergencies (hereinafter - the document confirming the full course of vaccination), issued in English or translated into English.

In the availability of the above documents or certificates, a person IS RELEASED from self-isolation or any quarantine restrictions.

In the absence of the above insurance policy (certificate,) and / or negative result of COVID-19 testing (the document confirming a full course of vaccination) the authorized official of division of protection of the state border refuses the foreigners and stateless persons to cross the state border of Ukraine, as stated by Article 14 of the Law of Ukraine "On Border Control".

At the same time, foreigners and stateless persons arriving from the Republic of India, the United Kingdom of Great Britain and Northern Ireland, the Russian Federation, the Portuguese Republic are subject to the additional requirement – a negative result of SARS-CoV-2 coronavirus antigen test, performed at the checkpoint (control point) of the state border of Ukraine.

Additionally, we would like to inform you that the Health Care and Medical Support Department of the Ternopil City Council will provide assistance in performing PCR tests on a commercial basis on the basis of the Ternopil Regional Center for Disease Control and Prevention of the Ministry of Health of Ukraine.
